

PERFORMANCE

Fund Objective

Capital appreciation and risk mitigation which is intended for an investor with a moderate risk tolerance.

Fund Strategy

The Fund invests in fixed income securities and long call or long put options on an index, ETF, or equity. The fixed income assets of the fund may invest in fixed income securities—including U.S. Treasury and agency bonds, corporate bonds, mortgage-backed securities, commercial mortgage-backed securities, and asset-backed securities. The Fund is expected to maintain a dollar-weighted average duration of between 1 to 10 years. The fund typically invests at least 80% of its assets in bonds and bond instrument securities or ETFs investing in bonds and bond instrument securities. The remainder of the fund is invested in long call or long put options on an index, ETF or equity (the “Reference Asset”) (the “Options Overlay Strategy”). The Options Overlay Strategy is designed to provide a level of capital appreciation opportunity when the Reference Asset appreciates in price. The manager attempts to limit risk associated with the Option Overlay Strategy by limiting the weight of the total Options Overlay Strategy to no more than 20% of the Fund.
