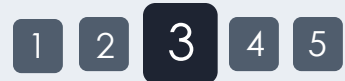
**FUND OBJECTIVE**

**FUND STRATEGY**

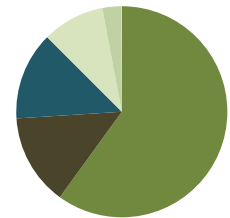

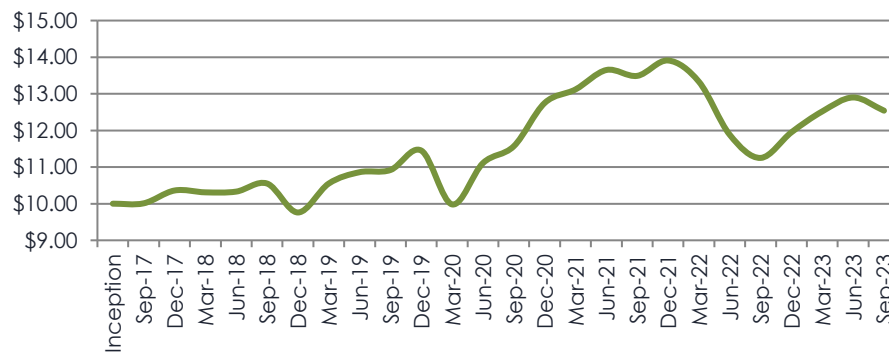

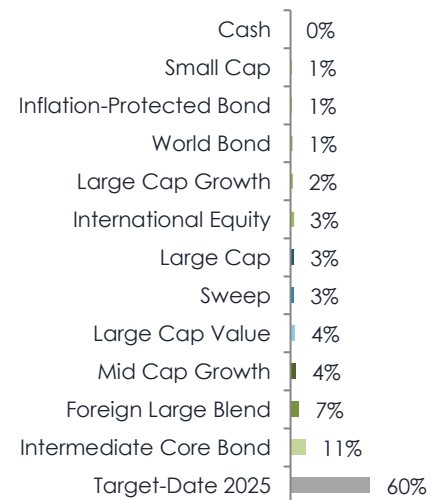
