FUND STRATEGY

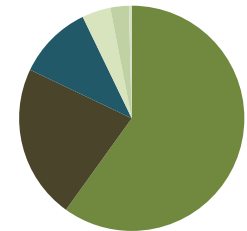

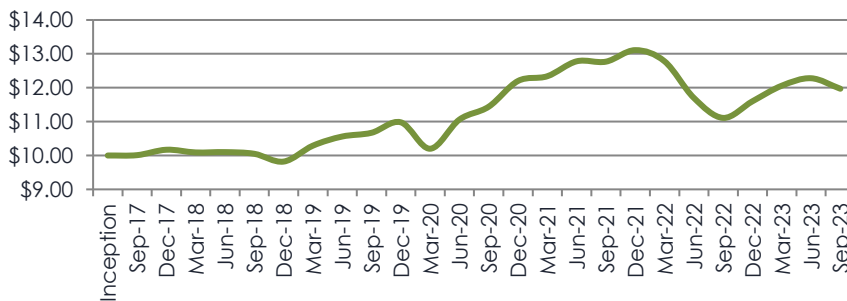

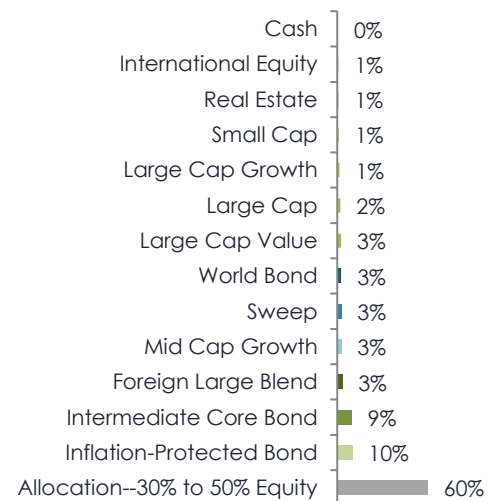
