FUND OBJECTIVE

The Fund seeks to provide long-term capital growth primarily through exposure to U.S. Small Cap Growth stocks.

FUND STRATEGY

The Fund primarily seeks to maintain exposure to U.S. Small Cap Growth stocks, while seeking to protect the Fund's downside using the Brandywine Risk Replacement overlay strategy. The Fund further seeks to pay for the cost of the put options used in the Risk Replacement strategy by investing in a broadly diversified Return Driver based portfolio.




