### FUND OBJECTIVE

The FHTC Moderate Conservative Fund seeks to provide current income and some capital appreciation.

### FUND STRATEGY

The fund invests in mutual funds, ETFs, and other CITs that reflect an allocation of approximately 60% of the fund's assets to bonds and 40% to common stocks. Subject to market conditions, the fund may have short periods higher cash holdings to reduce overall risk. The fund's indirect stock holdings are a diversified mix of U.S. and foreign large-, mid-, and small-capitalization stocks. The fund's indirect bond holdings are a diversified mix of short-, intermediate-, and long-term U.S. government, U.S. agency, and investment-grade U.S. corporate bonds; cash; mortgage-backed and asset-backed securities; and government, agency, corporate, and securitized investment-grade foreign bonds.

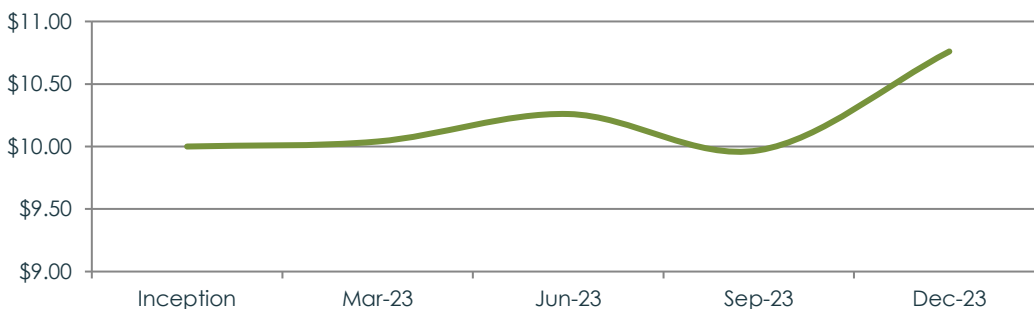

### FUND PERFORMANCE CHART



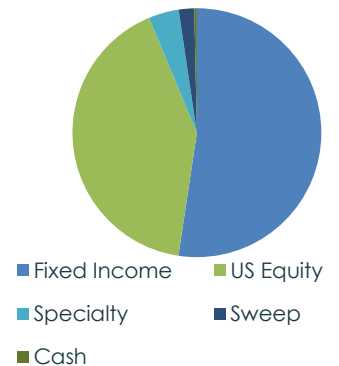

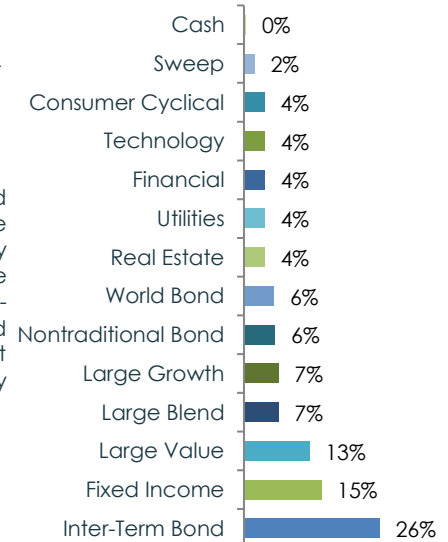
