### FUND STRATEGY

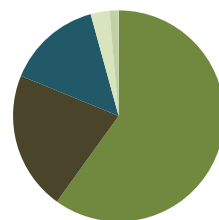

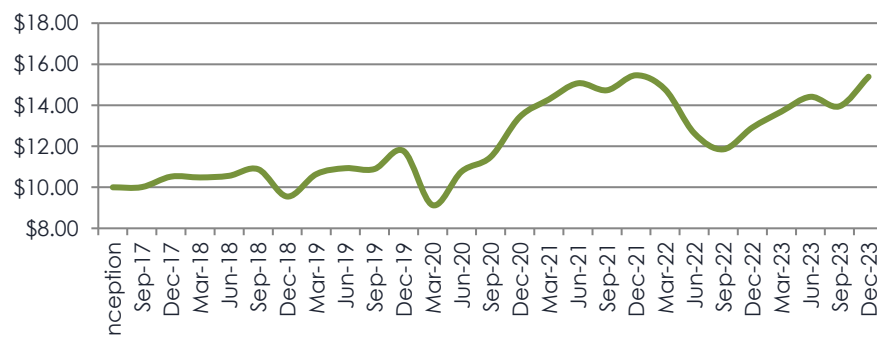

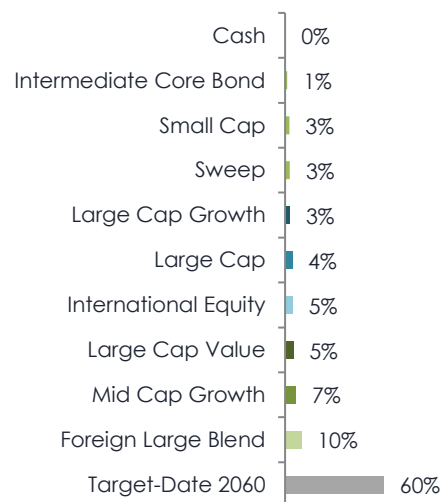
