## FUND STRATEGY

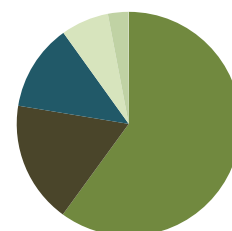

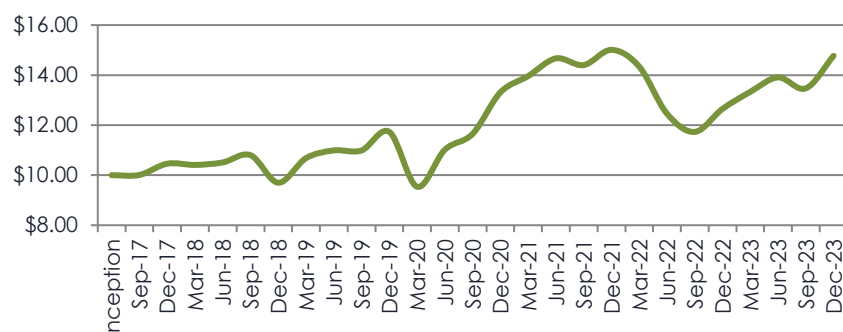

## PERFORMANCE CHART



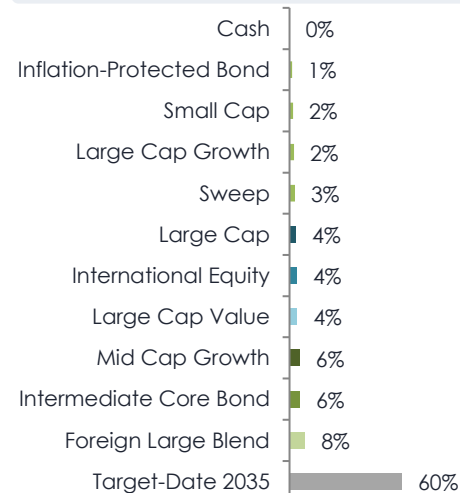
