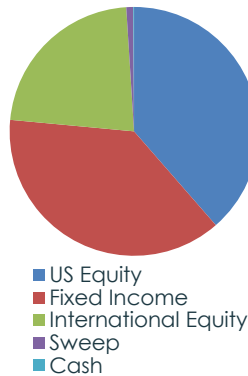

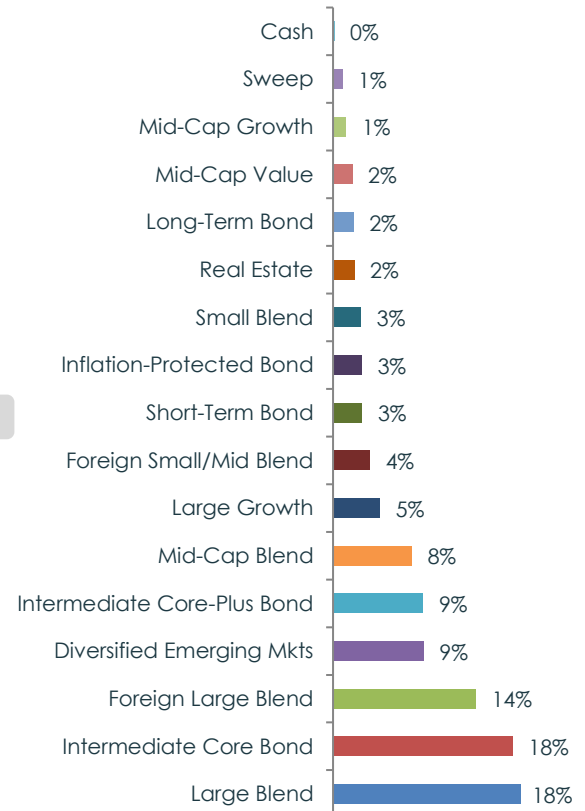

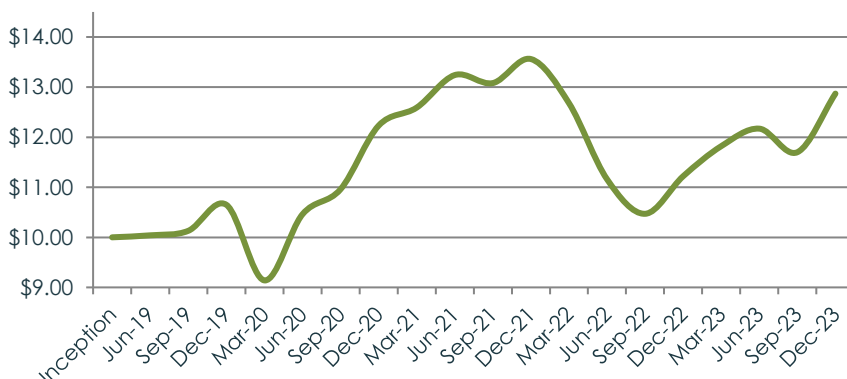
CIT ALLOCATION
