FUND OBJECTIVE

The FHTC Aggressive Growth Fund seeks to provide capital appreciation.

FUND STRATEGY

The fund invests in mutual funds, ETFs, and other CITs that reflect an allocation of approximately 10% of the fund's assets to bonds and cash and 90% to common stocks. Subject to market conditions, the fund may have short periods higher cash holdings to reduce overall risk. The fund's indirect stock holdings are a diversified mix of U.S. and foreign large-, mid-, and small-capitalization stocks. The fund's indirect bond holdings are a diversified mix of short-, intermediate-, and long-term U.S. government, U.S. agency, and investment-grade U.S. corporate bonds; cash; mortgage-backed and asset-backed securities; and government, agency, corporate, and securitized investment-grade foreign bonds.




