FUND OBJECTIVE

The primary objective is to minimize losses where possible, and especially losses that may exceed the applicable target drawdown parameter. The Target Drawdown 16 fund seeks to limit the range of fund volatility (target drawdown) to approximately 16% from the fund's last high-water mark to its


FUND STRATEGY

The fund is weighted toward higher beta growth assets such as domestic and international equities and fixed income, real estate, commodities, and the US dollar during all but the most unfavorable market conditions. It is designed to emphasize stability by utilizing Cabana's proprietary algorithm to identify the underlying investments that are deemed attractive at a given time within the economic cycle. It is the most aggressive of the funds in the Cabana Target Drawdown CIT Series.

TARGET DRAWDOWN



Drawdown is defined as the maximum loss, or amount an investment can be expected to fall, from peak to trough during adverse market conditions. Cabana numerically quantifies acceptable levels of risk by identifying a target drawdown percentage for each portfolio at the onset of the investment process and strives to stay within that range throughout all market conditions. Fund drawdown is calculated using end-of-month returns. Identified Target Drawdown percentages are targets, not guarantees.
