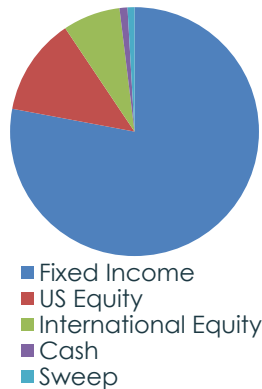

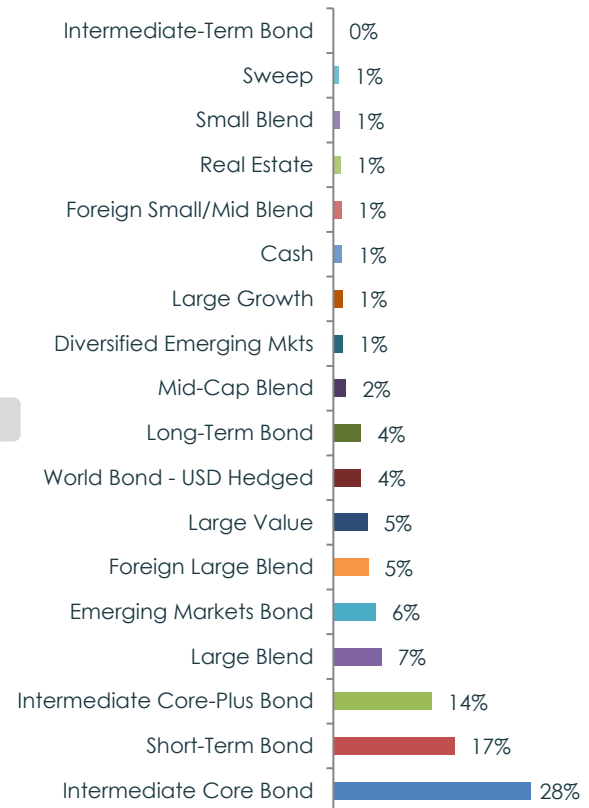

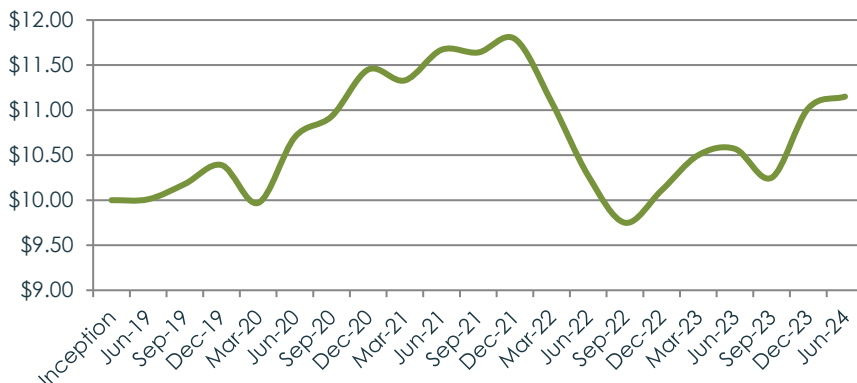
CIT ALLOCATION
