Long-term capital appreciation with a focus on limiting volatility. May be appropriate for investors seeking long-term growth of assets with time horizons longer than 5 years.

FUND STRATEGY

The fund will invest using a core tactical strategy. The core investments will consist of lower volatility equities and fixed income investments. The core will be a variable percentage of the portfolio from 40-100% of total investments. The tactical investments will represent opportunity sectors or investments that the investment manager believes will outperform the general market over the next market cycle.
